## 6. Report from Alumni Relations office (Ms. Whitney Fordham)

The Manager of AR presented the highlights of the work of the office over the last year:

- Affinity programs: Merit Travel, UFV Ring program moved to Bookstore, and launched new merchandise, carried through the UFV Bookstore
- Launched in summer 2014 the new Alumni Association logo with rebranding all promotional advertisement promotions: Alumni Association Rack cards; a new header for the Alumni eNewsletter; new certificates for the Distinguished Alumni Awards; displays for the Alumni Hall TV Monitors, etc.
- Top 40 Alumni campaign: UFV's Top 40 Alumni were named and featured at the Giving Thanks event in October 2014 as well as in a special addition of Skookum in spring 2015
- Installation of UFV's new chancellor, Dr. Gwen Point. Participated in the chancellor installation ceremony in February 2015
- Managing a growing database of over 32,000 alumni records (over 19,000 mailing addresses; 22,000 valid phone numbers; and 14,000 email addresses)
- Alumni eNewsletter 10 times a year; the Alumni Association Facebook page went from 386 likes on April 1, 2014 to 657 likes on March 31, 2015. The page is now at 784 likes; the Alumni Association Twitter page now has 382 Twitter followers
- Alumni Relations office participated in at least 20 alumni related events in various capacities on behalf of the Association (including Convocation; Commemorative Wine Launch; and the newly launched Alumni Expert Panel Speaker Series last March on the topic of Breaking into The Financial Industry; 9 Alumni Association Board meetings (including AGM, Board workshop day)
- Launched a new UFV Alumni website in June 2015
