Mentorship- rebuilding. UFV Lead still going strong. Sheila McKay is taking on student groups and is thinking of inviting alumni back to reengage. Looking into 30 min. mentor sessions, "what I wish I knew then" (ask alumni at pub night?).

Governance- onboarding three new board directors, orientation session upcoming, revising nomination package to be more intentional with recruitment.
